# Job Responsibilities

- Ensure compliance with all railroad rules and regulations for safety, operations, and the Federal Railroad Administration (FRA). Comply with the guidelines set forth by the FRA on Personal Blue Signal Protection of Workers.
- Inspect equipment components for compliance with FRA, Association of American Railroads (AAR), APTA (American Public Transportation Association) standards.
- Diagnoses malfunctions in diesel engines, air equipment, trucks or other components to determine nature of the problem and needed repair or replacement.
- Perform emergency repairs to locomotives.
- Replaces locomotive and diesel engine components including but not limited to wheels or trucks, traction motor combos, springs, couplers, draft gear assembly, cylinder heads, air compressors, turbo chargers, and other locomotive components.
- Performs daily service of locomotive units: fuel, water, lubricants, oil; wipes down and cleans unit/windows; checks supplies and drinking water.
- Performs periodic and annual inspections and understands FRA regulations in compliance with Title 49 CFR 229.
- Operate hoists, fork lifts, car moving equipment, and other various vehicles.
- Operate welding equipment; operate acetylene torches for cutting and/or shaping metal parts.
- Maintain written and computer records for maintenance and repairs as required.
- Uses appropriate machinery and software applications to complete assigned jobs.
- Develops and maintains records for projects and repairs.
- Maintains clean and orderly work space.
- Performs other related duties as assigned such as:
  - Transloading
  - Track maintenance and repair
  - Snow removal
  - Post-storm debris clean up
  - Other duties as necessary

## **Minimum Requirements**

- At least 18 years old
- Ability to read and interpret engineering blueprints
- Advanced mathematical and engineering skills
- Ability to lift and manipulate large metal objects
- Ability to stand for long periods
- Ability to read and write in English
- Ability to read and comprehend all instructions including operating rules, bulletins, regulatory documents and other written communications
- Proficient verbal and written communication skills

#### **Physical Requirements**

- Must be able to mount and dismount moving equipment
- Stoop/bend/kneel/crouch/crawl/balance/climb
- Work in cramped, confined, enclosed, or awkward places
- Ride on the outside of rail equipment for long periods of time
- Walk long distances over uneven terrain
- Demonstrate auditory and visual acuity/tracking/inspection
- Frequent lifting up to 50 lbs

## **Job Requirements**

- Self motivated, good work ethic, and positive attitude
- Work safely to prevent on the job accidents and injuries
- Wear protective equipment such as hard hat, hearing protection, or safety-toe boots
- Work hours may include a nonstandard workweek, overtime, and various shift work
- Work hours are based on seniority, new hires may work nights, weekends, and holidays
- Federal regulations require random testing for drugs and/or alcohol
- Must pass all required assessments
- Must pass a background screening
- Strict disciplinary policy regarding inability to report to work within proper time frame
- Must pass a post-offer medical examination, including a drug test
